### **SECTION 1 – INTRODUCTORY MATERIALS**

#### 1.0 <u>Purpose</u>

The Florida Department of State is seeking bids from qualified vendors to remove old shutters and install new shutters that are painted on both sides at the Brokaw-McDougall House, 329 Meridian Road <u>Street</u>, Tallahassee, Florida.

# Respondents are responsible for thoroughly reviewing the specifications of this Invitation to Bid.

#### 1.1 <u>Definitions</u>

The following terms used in this Invitation to Bid ("ITB"), unless the context otherwise clearly requires a different construction and interpretation, have the following meanings:

- 1. <u>Certified Minority Business Enterprise:</u> A business which has been certified by the Florida Department of Management Services, Office of Supplier Diversity, in accordance with Section 287.0943 (2) (e), Florida Statutes and Chapter 60A-9, Florida Administrative Code.
- 2. <u>Contract</u>: The agreement entered into between the Department and the successful Respondent after completion of the Invitation to Bid process.
- 3. <u>Deliverable</u>: A tangible, specific, quantifiable and measurable event or item that must be produced to complete a project or part of a project directly related to the scope of services.
- 4. Department: The Florida Department of State (DOS).
- 5. FY: The State of Florida's Fiscal Year, July 1 thru June 30.
- 6. <u>Bid/Proposal/Response:</u> All information and materials submitted by a Respondent in response to this ITB.
- 7. <u>Respondent</u>: Means a potential Vendor/Contractor acting on their own behalf and on behalf of those individuals, partnerships, firms, or corporations comprising the Respondent's team who submits a bid to this solicitation.
- 8. <u>Vendor/Contractor:</u> Any firm or person who submits a bid to the Department in response to this ITB
- 9. <u>Vendor Bid System (VBS)</u>: The system which allows all state agencies to advertise solicitations and exceptional purchases on MyFlorida.com. It also permits registered vendors to receive automatic email notification of solicitation advertisements, addendums to solicitation, and exceptional purchases.

#### 1.2 Contract Term

The contract shall begin on or about May 30, 2018. All project work specified herein shall be completed within ninety business (90) days of the successful vendor's receipt of a purchase order/contract.

#### The resulting contract may not be renewed.
