#### **SECTION 3.0 SCOPE OF SERVICES**

#### 3.1 Background:

The Bureau of General Services is responsible for the security of the Department's CCOC and Hamilton Park buildings. This includes the provision, maintenance, and monitoring of equipment for access control, entry detection, building surveillance, and the reporting of emergency situations. The existing equipment located at the CCOC and Hamilton Park buildings were installed in 1999.

The new system will need to integrate with an approximate amount of 144 existing door locks, 144 readers, 23 window break sensors, recording hardware, and 64 32 cameras.

- Q1) Can you please provide a list of the existing cameras we must integrate with? (brand, model or part #)
- A1) Yes Analog Box Cameras with Environmental Housing for exterior and Analog Dome Cameras for interior, all tied back to a new Hybrid 3Xlogic NVR(s) for recording and integration into access control.
- Q2) Can you please provide a list of the existing readers we must integrate with? (brand, model or part #)
- A2) Yes HID Card Reader, OP10HON
- Q3) Can you please provide the existing software managing the access control?
- A3) Yes S2 Access Control System
- Q4) Can you please provide the existing software managing the video surveillance?
- A4) Yes S2 NetVR version 8.4.2.111542
- Q5) Can you please provide the existing software managing the entry detection?
- A5) Yes Sonitrol Security System w Impact Activated Audio, integrated with the S2 access system
- Q6) Can you please provide information on the existing recording hardware?
- A6) S2 Security P#: S2-NETVR500-32
- Q7) Can you please provide drawings of all locations with locations of cameras, card readers, intrustion detection, and any other related equipment?
- A7) No
- Q8) Can you please provide a picture and/or information from the access control ID card box so we fully understand the credentials being used today?
- A8) The cards come in a plain white box. The cards are: HID Prox Card 35
- Q9) Can you please provide the manufacturer(s)/model number(s) of the badge printer(s) that are in use today
- A9) Brand: Fargo Electronics/HID Corp. Model#: DTC550 2 Sided 91820
- Q10) No specific product specs were listed, therefore is DOH asking for a completely new state of the art and monitored Access control system with Integrated Security for intrusion, (new panels, software, licenses, etc) and integrated with existing CCTV Cameras?
- A10) No, we want as little hardware changed as possible to make it where we have a system that can be monitored by various monitoring vendors.



Q11) Will DOH in order to save money (no need to reissue photo ID Cards) allow the existing access control card readers and electronic locks to remain in place and be cut over to the new access system?

### **A11) Yes**

- Q12) Or will you require a refresh of card readers that have been in place nearly 19 years. Formats and other security enhancements have been implemented over the years to help reduce 'cloning' of cards.
- A12) No, it is the intention to retain readers and badges.
- Q13) You don't have a problem with what you have in place as far as the system? Its just that there's some problem with there? Overall is the S2 system working for you?
- A13) No. Yes, but we would like a system in place where we can bid out the monitoring.
- Q14) Our bid would include a non-proprietary security system to integrate with your current equipment. Is that what you are looking for? You are happy with your access control system if I'm hearing you right?
- A14) Yes
- Q15) My definition of monitoring is that an alarm goes off, a window breaks, the police are alerted and show up. Is that your definition of monitoring?
- **A15) Yes**
- Q16) Can you provide a list of interior and exterior cameras?
- A16) Please refer to A1
- Q17) How many exterior cameras?
- A17) There are 17 exterior cameras.
- Q18) If we need to add a new device, I noticed some cameras are not working, will we be replacing cameras?
- A18) There are currently 32 working cameras, but we may add, replace, upgrade cameras in the future
- Q19) Can you provide information about ADA information on the push button doors? Who is the vendor?
- A19) Yes, DCI is the vendor for the ADA buttons and access.
- Q20) Is there a central location where someone is monitoring the access control system? So when an alarm goes off is there a guard station that is alerted?
- A20) No, just the monitoring company
- Q21) That applies to door props? Is there anyone looking at a computer screen watching events as people swipe in?
- A21) No, all monitoring is through the monitoring company.



- Q22) Majority of buildings have glass break detectors. Are these glass breaks 24 hour where someone is monitoring and dispatched if there's a problem or does someone come in the morning and turn off the alarm?
- A22) The monitoring company notifies us of glass breaks.
- Q24) When you guys say "integration" in the statement of work are we looking for if the glass break detector goes off are we looking for a phone call or an email event where an email is sent to a security supervisor on staff?
- A24) If there is a glass break the monitoring company will call us. Or automatically replace them if they go bad
- Q25) I noticed wireless equipment in the equipment rooms. Do the front desk personnel have wireless panic buttons?
- A25) No. Some programs have wireless remotes to unlock doors in their suites to allow access.
- Q26) Many of the cameras you have on site now are blacklisted by the federal government because they are a hackable system, where are the specs going to be written?
- A26) We are keeping the current cameras, therefore, there are no spec.
- Q27) A lot of access control manufacturers allow traffic on the network. Are we allowed to provider an access control system that only allows outbound traffic on our network for cloud based services?
- **A27) Yes**
- Q28) Fundamentally are you looking to replace everything we saw yesterday and today with a fully integrated system. Are you kicking Sonitrol to the curb and wanting a non-proprietary system? What's the ultimate endgame for the Dept of health?
- A28) Refer to A10
- Q29) I saw a book in the equipment room that has a list of everything Sonitrol has in the buildings. Can copies of that information be made available so you can get a proper price?
- A29) No
- Q30) Are you looking for eternal access to video from mobile devices?
- **A30) Yes**
- Q31) Will we be allowed to return to perform a detailed analysis to comply with the specifications on equipment set forth in Task List 3.2.1.1.1 & 3.2.1.1.2?
- A31) No. Timeline is specified in bid to review existing equipment.
- Q32) How do I get the time to examine the system to make the system work?
- Q32) It is unnecessary to examine the system. All current equipment that new equipment is to be integrated to is currently working as it should.
