Should weather cause delays in obtaining dive footage, the Vendor should bear in mind that interviews of archaeologists, topside b-roll, and interviews of locals and dive shop partners may still be achieved in the interim. While the archaeologists are limited to travel dates, the Vendor may choose to return on their own time, at a later date for underwater filming provided the product is received by June 15, 2018.
