The Department is seeking a Vendor to provide transportation services for inmates who are released from its custody and care. The Vendor shall provide vehicular transportation to any destination in the State of Florida or United States that the Vendor and its interline partners serve. If a destination is not served by the Vendor, or interline partner, the Vendor will notify the Department of the closest point possible to the intended destination and the Department will decide if that destination will meet its needs. The Vendor shall pick up released inmates at a location mutually agreed upon by the Vendor and the Department. The Vendor will not be responsible for providing transportation to the Vendor's facility unless mutually agreed in advance. The Vendor shall inform the Department of the scheduled pick-up time for each facility within three (3) hours of being provided the release information. The Vendor shall comply with all State and Federal motor vehicle regulations pertaining to public conveyances, including the proper licensing of drivers and proper maintenance to provide adequate and safe vehicles. The Vendor shall provide assistance for any inmate with physical disabilities in boarding and/or departing the vehicle.

<u>Justification for single source acquisition</u> (what is necessary and unique about the product, service or source; steps taken to confirm unavailability of competition, as appropriate):

Greyhound Lines, Inc. is the only source that can:

- Pick up at all of the Department's designated locations;
- Provide the most economical means of meeting the needs for post-release transport of inmates, as required by Section 944.611, Florida Statutes (F.S.); and
- Maintain a statewide and interstate destination network that can meet the needs for post-release transport of the Department's inmate population.

The Department has conducted research on other potential transportation services and found none with the infrastructure to meet the requirements of statewide pickup locations and nationwide drop-off locations. Additionally, Greyhound has dominated this industry for decades and it is not feasible that another company would be able to establish the necessary infrastructure required for transportation on this large scale within a five-year period.
