Also is this a Front Load Dumpster or roll off container?</p>	<p>The main waste stream consists of the following:</p> <p>The Self Contained Compactor: Municipal Solid Waste (MSW), Construction and Demolition (C&D), and bulk, is a 35 cubic yard self-contained compactor, walk-up.</p> <p>The Municipal Solid Waste (MSW), Construction and Demolition (C&D), and bulk, is a 40 cubic yard open-top container, walk-up, and roll off dumpster.</p> <p>Municipal Solid Waste (MSW), Cardboard, and Single Stream Recycling, is a 2 cubic yard open-top container with lid for the water plant disposable waste.</p>
2	<p>Do you have the average weights or the monthly/annual weights from the past year for each container? Your incumbent bidders will have access to the actual weights which will place new bidders at an disadvantage. With the Freedom of this Information it will allow us to get the best rates possible even though they may vary.</p>	<p>This year the compactor executed 246 tons with an average of 24 tons/month of general population trash.</p> <p>Information is currently not available for the 40 cubic yard open-top container and the 2 cubic yard open-top container with lid. If this information becomes available the Department will issue a subsequent addendum.</p>
3	<p>Does the 35 cu yd Self container compactor have a standard "Dog House style" walk up to the hopper configuration? Or is it through the wall?</p>	<p>It is a "walk-up" to the hopper type of configuration.</p>
