SCOPE OF WORK:

Base Bid:

The contractor shall provide all labor, materials, equipment, supervision, and permitting to successfully remove the existing roof to decking and install the new roof, including removal of skylights and installation of new skylights, on building BL041002 as per the construction documents.

Alternates:

The contractor shall provide all labor, materials, equipment, supervision, and permitting to successfully remove existing roof to decking and install new roof on building BL041001 as per the construction documents. **If this alternate is accepted, 30 days will be added to the time for substantial completion.**

Builder's Risk Insurance is required for this project and must be included in bid price.

Note: Bidder Prequalification is required for all bids. Each bidder shall provide a copy of its biennial pre-qualification letter from FDEP's Bureau of Design and Construction. If not pre-qualified, the bidder must submit a current State Contractor license certification or registration and current Corporate Charter registration with the bid.

Pursuant to Executive Order 07-126 and Section 255.252(3), F.S. the Department requires the proposed project be designed and constructed in accordance with green building standards where applicable.

Failure to file a Notice of Intent to Protest or a formal, written Protest in accordance with Rule 28-110, F.A.C., within ten days after the 72-hour period ends, as prescribed in Section 120.57(3), Florida Statutes, shall constitute a waiver of your right to an administrative hearing on the Bid Specifications under Chapter 120, Florida

Statutes. Rules for bid protests can be found in sections 120.569 and 120.57, F.S., and Chapter 28-110, Florida Administrative Code. A bid protester shall comply with these statutes and rules.
