The following shall address questions, responses, additions, clarifications, and/or changes relative to **FDVA-ITB-20-022B**. The below questions, responses, additions, clarifications, changes, and/or attachment(s) shall amend **FDVA-ITB-20-022B**.

The following serves to **(remove)** and **replace** FDVA-ITB-20-022B, Statement of Work, pages 14-15, #15. Equipment Specifications, Section 15.1, paragraphs 15.1.1, 15.1.2 and 15.1.3.

15.1 The following televisions and universal remotes are to be **(supplied and delivered as specified)** **supplied, delivered and install on pre-existing mounts as specified** at the Ardie R. Copas State Veterans' Nursing Home located at 13000 W. Tradition Parkway, Port St. Lucie, Florida 34987.

15.1.1 **(Supply and deliver)** **Supply, deliver and install on pre-existing mounts** one hundred twenty (120) LG Brand Size 43 inch televisions, Model 43LT572M, Hospital Grade, Vesa (A X B) 200 X 200mm, pro centric or FDVA approved equivalent that shall be compatible to TV Bracket as specified in attached Exhibit-A, page 33.

15.1.2 **(Supply and deliver)** **Supply, deliver and install on pre-existing mounts** twelve (12) LG Brand Size 65 inch televisions, Model 65UT770H, Hospital Grade, Vesa (A X B) 600 X 400, pro centric or FDVA approved equivalent that shall be compatible to TV Bracket as specified in attached Exhibit-B, page 36.

15.1.3 **(Supply and deliver)** **Supply, deliver and install on pre-existing mounts** ten (10) LG Brand Size 49 inch televisions, Model 49UT660HOTA, Vesa 300X 300, pro centric or FDVA approved equivalent that shall be compatible to TV Bracket as specified in attached Exhibit-A, page 33.

15.1.4 **Supply and deliver** three (3) universal programming remotes that will control LG Brand televisions Models 43LT572M, Model 65UT770H and 49UT660HOTA or FDVA approved equivalent.

The following serves to answer questions submitted by contractors.

- 1) **Vendor Question:** Good morning, on bid #FDVA-ITB-20-022B what type of jack do you need on the pillow speakers, ¼” would be the standard and is an 8’ cable long enough?

FDVA Response: The ¼” jack and 8’ cable is acceptable.

- 2) **Vendor Question:** In regards to the LG model 43LT572M, 120 units for the Port St Lucie location and the 112 units for the Orlando location, we are finding inventory to be low and the pandemic has impacted production as you can imagine. Can the LG model 43LV570M be used as an approved equivalent?

FDVA Response: LG Model 43LV570M is approved equivalent.
