(2) A Uniform Alcohol Influence Report, FDLE Form AIR 1 - March 2004, is

adopted for use by all law enforcement agencies in the State of Florida when making DUI arrests pursuant to section 316.193, Florida Statutes.

(3) This rule shall not preclude the use of other probable cause affidavits or alcohol influence

reports, and law enforcement agencies are authorized to supplement the Uniform Probable Cause

Affidavit or the Uniform Alcohol Influence Report with additional affidavits and reports.

(4) Failure to use the Uniform Probable Cause Affidavit or the Uniform Alcohol Influence

Report shall not prohibit prosecution of a person arrested for a violation of section 316.193,

Florida Statutes, and shall have no effect on the legality or validity of such arrest.
