6	meeting. Before we begin with business, does
7	anybody have anything they want to add for the good

14	MS. LONGMAN: Good morning. Debbie Longman,
15	Department of Revenue. The Department will have

17	Item Number 1, the Department will be
18	requesting permission to file notices of proposed
19	rule to amend rules related to general tax
20	administration. The proposed amendments revise
21	language and forms to reflect statutory changes
22	enacted by the 2016 Legislature, update our annual
23	tax rates, and clarify forms to improve
24	readability.
25	A rule workshop was scheduled for September

21st, if requested. No request was received and no workshop was held. No written comments were received by the Department. I'll be happy to go through them, but since I did this at our Cabinet Aides meeting at the end of September, it's your call. Any questions? MS. OLSON: I think we're good. MS. LONGMAN: That concludes the Department's agenda. Thank you. MS. OLSON: Thanks, Debbie. \* \* \*

## DEPARTMENT OF VETERANS AFFAIRS

MS. OLSON: Next up is Veterans' Affairs.

MR. CLARK: Good morning, everyone. I'm Roy Clark with the Department of Veterans' Affairs. We'll be bringing five items for the Cabinet consideration.

Agenda 1 in your packet there will be our meeting minutes from the 2nd of August. We have no corrections to those, and we'd ask that the Cabinet approve them as stated.

Agenda Item Number 2 is September the 20th meeting. Again, we have no corrections to offer and would respectfully ask that the Cabinet would approve those as stated.

16 Do y'all have any questions on the minutes 17 yourselves?

18 (NO RESPONSE).

MR. CLARK: Okay. Good.

Agenda Item Number 3 will be our third quarter report. It's, you know, been a long time since the third quarter; but if you don't mind, I'd like to just highlight a few things out of that quarter.

Beginning on Page 3 in the packet, we provided

you, we continue to show where our Division of Benefits and Assistance worked very hard to outreach. In the Bureau of Claims, that's where veterans come in from the counties or wherever. We get the claims in the office down in Bay Pines. They serviced over 67,000 during that quarter; 8,600 claims for benefits during that third quarter; and we had 310 veterans we went before the Board of Veterans Appeal to appeal their ratings, so a very successful quarter.

The field services, these are the folks that 11 12 are out in the field actually contacting veterans 13 at military appreciation days, you know, bases have 14 open houses, et cetera, we always have somebody out 15 there to provide information. The types of things, 16 maybe just, you know, how to get a handicapped 17 placard for your card, eyeglasses, things that they 18 may not be aware of that they've earned that 19 they're entitled to. And then we also give them 20 the location of the local county service officer or 21 VA hospital where they can go and get more 22 information about that.

23 So we turned about -- we had 200 events at 24 that time, and there were 7,700 -- almost 7,800 25 veterans and their families, and we worked over

7 1 8,000 disability claims from those events, so 2 they're very -- they are very successful. 3 On Page 4, I'd just point out to you once 4 again that we've begun to work on the nursing home 5 in Port St. Lucie. The 35-percent design has been 6 approved as we stated in the last meeting with 7 y'all I believe which released money for the 8 100-percent design, and we're well into that. 9 On the Lake Baldwin, the good news is the 10 Federal VA found the title. The Department of Navy 11 was holding it through the Corps of Engineers in 12 Jacksonville. So our Division of State Lands now has it and they're reviewing that to make sure 13 14 we've got a clear title, okay? 15 Over on -- skip on over to Page 9. I'll talk 16 a little bit about Veterans Florida. As many of 17 you know, Bobby Carbonell through an initiative by 18 the Legislature has established the Florida is for 19 Veterans Foundation, and they're doing great work. 20 In the first quarter of this year, they began their 21 vets training. He reached out to over 61 22 businesses, eight of which submitted applications 23 and were approved. And he set aside \$987,000 to 24 pay for training. 25 What we do here is the businesses agree to

hire veterans, and we'll pay up to \$8,000 for their training to learn whatever is the job that they're being hired into. Some of these businesses include Lockheed Martin, Navy Federal, Baptist Hospital, the Cheney Brothers, which is a large food distribution company down in south Florida. All have agreed to hire up to a hundred veterans and then -- so we've set aside that money to cover that training. They invoice him, they prove that they -- you know, they prove that they've hired the veteran and then we pay them.

12 The second item there, Item Bravo, is the 13 entrepreneurialship program that has really taken 14 off. We had over 600 applications, 400 qualified. 15 The process was they would begin the education 16 process online, and through that we've learned that 17 it's better to get them into the classroom early 18 on; so we've kind of changed that. But during this 19 quarter, it was online, and 162 came out on the 20 other end and started their businesses. And I'll 21 talk more about that when I talk about the fourth 22 quarter.

And then finally, on the Page 11 and 12, I'd like to point out that the Florida Veterans' Foundation, which is our DSO, got a grant thanks to

the Attorney General's Office of \$1.25 million from a lawsuit settlement, and they have begun to reach out to homeless and hard-case veterans around the state to prevent them from becoming homeless. We allow them in the bylaws to write a check up to \$1,200 to meet an immediate need. And that's what they've been doing, they've been very successful.

8 During the first quarter, they reached out to 9 over 60,000 veterans and families, and they spent 10 about \$60,000 helping those folks. So we 11 appreciate that grant, and we appreciate y'all's 12 interest in them and helping us help them do what 13 they need to do.

Any questions on the third quarter? Anything caught your attention?

MR. CLARK: The fourth quarter, same thing. Page 2, just point out that Colonel Sutphin was named the interim director. That's since been -of course he's now the Director.

The claims office down in Bay Pines, they handled over 108,000 claims that quarter. Why so many? Well, we get the visitors from up north who come down and spend the, you know, spring months with us; and so they tax our system a little bit,

but you can see those numbers.

The Bureau of Field Services, these are the guys, once again, going out touching veterans in any kind of event that we could get to, training them up. They went out to 233 events, touched over 10,000 veterans and provided 89 hours of support to the Governor's Veteran Service Award ceremonies this quarter too, which is a great thing. The veterans love that when they get that medal. Some of them it's the first time they've ever been recognized for anything in the way of their service.

13 The Division of Homes on Page 4, I'd like to 14 point out we got a grant to install a lift system. 15 There's a picture on Page 5 of that system. What 16 that does, it allows the CNAs or the nurses to get 17 the patient out of the bed and get him to the bath 18 or wherever he needs to go with that lift system. 19 Some are very, very -- you know, are old-aged, 20 can't move, are not mobile, or they're heavy. And 21 we have cut down already on workers' comp claims 22 because of the safety this provides for the person 23 attending to the patient themselves.

24Okay. Over on Page 9, again, I'd like to just25point out some of the things that Bobby has done:

162 veterans are now working as a result of this entrepreneurial program he's got going on. You can go to his website, floridaisforveterans.org. There's a great story in there about five Green Berets that went through this training and have now opened their own distillery down in St. Pete.

7 We've got all kinds of businesses: You know, 8 construction, plumbing. A couple came together, 9 both were vets, they've opened a bed and breakfast; 10 and we've got restaurants. One young man has 11 created these ballistic panels that DOD is buying, 12 and you set them up on a platform and it makes a 13 ballistics shelter if you will. It instantly 14 becomes a tactical operations center where those 15 working inside are safe and sound. I mean just an 16 idea he had and worked through.

You know, we engage businessmen all over the state to mentor these guys, and the guy that was mentoring this guy liked the idea so much he invested in it. So you never know where this is going. So this is a good thing, and we appreciate all of y'all's help in making sure that happened.

One other thing I'll point out to you, very important, midway down, he has selected monster.com as his job search engine. And the reason he did

that is because they've got the one and only military skills interpreter. The computer works to figure out what a guy is doing. An 11 Bravo is an infantryman who you see in the movies with his boots, his rifle, and his backpack. If you put into any other search engine other than Monster, Inc., you simply get: Join the Florida Guard, or go to work in the prison system as a guard.

9 This factors in your rank, your schools, and 10 all the things; and so if you put that you were an 11 E6 staff sergeant, which means you had seven or 12 eight years of experience in the Army before you 13 got out, it immediately throws you up into 14 managerial level job searches, having to do with 15 security, et cetera. They're having a lot of luck 16 in the Miami area with personal bodyguard-type stuff, just because they're willing to work with 17 us, and so we're real excited about this. 18 Tt's 19 working really good, and we're excited for Bobby.

The other thing on Page 10 that he's done, he has begun with the Department of Highway Safety and Motor Vehicles and the Florida Trucking Association, we're going around the state holding rodeos, truck driver fairs if you will; where if you want to get a CDL license, you show up, you get

tested; the Highway Safety and Motor Vehicles folks bring their van out there, they test these kids, they bring their vehicles for them to drive. We've held them at Camp Blanding, Orlando, and down at St. Petersburg.

I don't have the numbers at St. Pete yet, it was just done here in October; I know 40 were tested. But in Orlando, in August, we had 30 tested and ten got their CDL license and got jobs because Florida Trucking is right there with their HR folks ready to hire and put them to work. So this has really been a success story.

16 MR. CLARK: Okay. The next thing we're going 17 to is performance measures. Ours have never been approved. I just handed you -- and I apologize, 18 19 but I just handed you, or Jessica did, a new sheet, 20 if you will. The measures have not changed from 21 what you've been looking at. We have changed the 22 data within the box and how we're going to measure 23 and the frequency by which we're going to measure 24 because this more reflects the Director's desires 25 and what he would like to present to the Cabinet

next week for approval.

2 The Number 1, 2 and 3, go to Colonel Sutphin's 3 concern that 35 percent of the veterans in this state don't know what their earned benefits are. 4 5 And so we're pressing very hard to reach out 6 through Number 1, which is the outreach events, and 7 I mentioned to you what those basically do. We go 8 and we set up a booth at any event that's being 9 conducted where veterans are likely to show up, 10 okay? And we help them with anything they might 11 If they want to sit down and do a disability have. 12 claim right there, we'll do it right on that spot, 13 okay?

14 Now the first quarter is low because once 15 against July, August and September, this is all the 16 first quarter data you're looking at with the exception of one, and I'll point that out when I 17 18 get to it. All of this is first guarter data, so 19 July and August are very hot. The elderly do not 20 go these events, we don't -- we can't touch them, 21 they just don't come. It's just too hot for them 22 because most of these are held outdoors.

23 So the numbers will go up. We feel that that 24 range, between 175 to 199, will be a good baseline, 25 but we intend to exceed that every quarter, all right?

1

2 So the reason we're asking for a guarter 3 versus a month is because when you get down to 4 Number 2, this is where the claims come in. This 5 is our Bay Pines folks. These are the 64, 65 6 veterans' claims examiners we have, plus their 7 supervisors. And this is where a veteran says I've 8 been wronged and he comes to us for help; or he 9 can't get his claim right, VA has denied it because 10 he's missing a piece of paperwork. And so our guys 11 get in there and work with them and make this 12 happen.

13 Now we went to a new data recording system. 14 VA made us go -- made everybody go to a digital to 15 digital. You cannot -- you can't paper trail it 16 any more, you got to -- computers have got to talk 17 to computers. And so Colonel Sutphin was getting 18 ready to sign the long-range performance plan and 19 realized that there was a drop significantly in the 20 first two months of the first quarter. And so 21 being the new guy on the block, he asked the 22 question: What happened?

And we began to dig down, and we realized that this digital-to-digital system the counties can't play. It's very expensive -- well, it's not

expensive, but they don't have the money to buy it. So what they're doing is still doing the paper trial and then sending it Data Spect to upload.

Data Spect's interpretation of a unique veteran is a one-time visit. If you or I go in and they put our name in the computer, that's it, we don't ever get counted again. And that's not an accurate reflection of what we do because I may have an additional claim or I may be unhappy with the claim that I submitted the first time and I want to redo it.

So the numbers for July were 2,005, and the numbers for August were 2,800; obviously a glitch in the system. And Colonel Sutphin caught that and said, okay, let's fix that.

16 So we've got it fixed now, and they're 17 counting them in the way that they should be 18 counted. And the number for September was 13,600, 19 which brings us up 18,000 during the guarter. Now 20 we're probably going to have to adjust that. 21 19,000 as a five is not going to be a fair and 22 accurate reflection because you can see in 23 September alone we did 13,000, and that number is 24 going to jump. So we may have to come back and 25 increase what the range is for you so it's a more

accurate reflection.

But both those two are where we touch them. This is where we tout ourselves as the premiere entry to the veterans system, is through the Florida Department of Veterans' Affairs and these we can control, we can press to test. And we think by doing it quarterly instead of monthly it does two things: One, it gives you a more accurate depiction of where we are as we move forward; and it -- you know, in the military there is an old adage that an organization only does well what the boss checks.

And so they know we're going to be checking this, and there will be months that are down a little bit so we may have to put a little more resources to it or whatever to get in that proper range. And I know I'm spending too much time on these, but they're for your consideration.

19The next one is our examiners, the turnover20rate. In FY 2014/15 it was as high as 28 percent.21Now we've got it down now because of -- since22Colonel Sutphin has come in, he's really forced the23issue. These guys are all retired military, and so24they have their military benefits. We don't pay25them a lot, about \$42,000 to do what they do, okay?

And they can get better jobs. And the example I'll give you is this week we lost four: One retired, okay; one went to a county, Sumpter County, because they'll pay him more; one went all the way to Kansas to get a better job with the Federal VA; and another one went right upstairs. We're collocated with the Feds there in Bay Pines. He just went upstairs and got a better job, more pay.

But we think that's an accurate reflection of how well we're doing as an employer, if you will, as a representative of this state by ensuring that we have got those positions filled and so we can touch and do what we say we're going to do in one and two, so we think that's a fair measure also.

15 Okay. In the homes, once again, it's very 16 high. Our CNAs, they leave, it's a tough job, it's 17 the hardest job in the home. We're basing these 18 numbers -- these ranges come from the Department of 19 Labor and the Department of Management Services, 20 which back in March reflected nine percent was the 21 average for the U.S. And so that's our goal, to 22 get nine percent or below. We're not there in the homes, it's tough. Now we're doing a lot of 23 24 things. The first thing we're doing is we're 25 trying to get AHCA to approve us to train in the

homes the CNAs, okay, actually train in the homes with our own personnel training them, approve the curriculum, approve our -- come and then certify them after they're trained; so we're trying to do that.

6 We've reached out to the colleges, 7 universities, community colleges where our homes are located. We've offered to let these young 8 9 people come into our homes and work with us, okay? 10 And if they become a state employee, of course, you 11 know, they can get some of their college taken care 12 of. And we'll give them plenty of hours on the 13 floors so they can get all the real live training 14 they need, and then we're going to ask them, 15 because of doing that, they'll come work for us for 16 two years after they graduate before they leave. 17 So Colonel Sutphin is trying to come up with all kinds of ideas to bring that number down. 18

And then on Number 5, again, the homes, we think quality of care is a fair measure. We can control that. You've heard him speak about he doesn't want it smelling like death or feces when he goes in there. And so we feel like cleanliness, proper care, et cetera, are things that we can in fact manage and control. The standard, the range is no Class 1 or 2. Class 1 is there's an imminent threat to the physical healthy or mental health of that patient, of that resident. Class 2 would be it's not an immediate threat but you've let this wound go too long, it should have been properly cared for in another manner.

We've had none of those. We did have to pay a \$6,400 fine because we failed to respond to AHCA in a timely manner on an issue they found, and so we counted one against us, but we feel we can stay in the five. Most of our homes have been five-star homes, and we think we can meet that without too much problem.

15 And finally, Number 6 is our Direct Support 16 Organization, and that's how many they reach out 17 and touch on a quarterly basis. One real quick 18 story on these guys. I'm going to tell you, they 19 do yeoman work. We had a lady call -- well, a 20 friend of hers called. She and her husband and 21 daughter and her two grandchildren were stuck in 22 North Carolina. They'd gone up there on vacation and he contracted C Diff, and she had \$75 to her 23 24 name and she'd overdrawn her debit card by \$600 25 already and they shut it off.

So we contacted the VA home and VA nursing -not nursing home -- hospital in Raleigh, got him in there, got him started to be treating. We got the customer service folks there to get her a hotel, they paid for the hotel for her. We -- our DSO, contracted with the hotel for a \$600 credit so she could eat. The room came with a breakfast voucher, so she had breakfast covered for the four of them, we took care of the dinners, and then we sent her two debit cards of about 150 bucks a piece so she could get gas and food to come back to Gainesville.



The good news is they checked him out on Monday and they're back in Gainesville, and he's in the hospital at Gainesville and she's home where she can live a normal life instead of trying to live out of a hotel.

18 That's the type of work these guys are doing, 19 and so we think that's important, and we think it's 20 a measure that's worth measuring for your 21 consideration each quarter. So subject to your 22 questions, that's all I have. I know it's a lot 23 and I apologize, but we've never, ever gotten these 24 approved, so it's time to get it taken care of. 25 MS. OLSON: Thanks, Roy.

1 2 DEPARTMENT OF HIGHWAY SAFETY AND MOTOR VEHICLES 3 4 MS. OLSON: Next up is Highway Safety. 5 Good morning. Jennifer MS. LANGSTON: 6 Langston with Highway Safety. 7 The Department has two items for Cabinet 8 consideration. Item 1 seeks approval of the 9 September 20th Cabinet meeting minutes. 10 Item 2 seeks approval of the Department's 11 legislative concepts for the upcoming legislative 12 session. Your offices have been briefed or will be briefed by the end of the day. If you would like, 13 14 I can go through them or answer any questions that 15 you have. 16 MS. MCKNIGHT: Jennifer. 17 MS. LANGSTON: Would you like for me to go 18 over them? 19 MS. MCKNIGHT: I would love that. Thank you. 20 MS. LANGSTON: Absolutely. 21 All right. I did mention that we're seeking 22 approval of our legislative concepts. This year 23 we're bringing 10 concepts for your consideration. 24 A couple of these you may have heard about last 25 session and they'll be repeats this year.

The first item relates to removing obsolete language. There's a truancy report that's on the books that requires a manual process, and now we have the automated process. So we'd like to clean that language up and make that a little bit tighter.

Our second concept relates to law enforcement training reimbursement. Right now current law allows for the Department to recover two years of training reimbursement expenses. This changes it to three years.

12 Our third concept creates a pilot program in 13 coordination with FDOT's traffic management to 14 allow for a pilot project for drones, and that will 15 enable us to be able to clear the roads quicker and 16 allow -- enable the public to travel during those blocked lanes, especially whenever we have those 17 18 larger crashes like commercial motor vehicle 19 crashes.

The next two concepts relate to compatibility issue with the Federal Government. Those address audit findings that have been noted to the Department.

24The next one is related to the international25registration plan, and what -- and again, that is

another compatibility issue, and that relates to apportioned vehicle definition. We want to make sure that our definition matches the Federal Government's definition. So effective January, the international registration plan noted that charter buses would no longer be exempt from the IRP. And so this actually went into effect in January, so we are making our definitions match.

9 The next one sounds very similar to the one I 10 just described, same type of vehicle. This relates 11 to the issuance of apportioned vehicles. Right now 12 these plates are issued for a one-year issuance 13 period. And these are those larger trucks, and so 14 we're working with the Florida Trucking Association 15 to -- this is a business friendly concept for the 16 Trucking Association so those plates can be on 17 there longer, so they don't have to change them out 18 as often on their fleets, make it less burdensome 19 for them.

The next item relates to transporter license plates. These plates, the law is not real clear on who is allowed to have them on the vehicles, and so we'd like to tighten that law up a little bit and make sure that the intent is there and what they're supposed to be using them for. Right now they're

issued but we're not able to gather a lot of information. We want to make sure that the businesses who are entitled to use those plates are actually the ones that are being issued them.

The next item is related to an expedited shipping service, right now we have an expedited shipping service for titles, and we don't have that same service and consideration for driver licenses and ID cards. And so this is a cost recovery issue to allow us to offer that expedited service to obtain the driver license or ID card whenever those folks are in a bind.

13 The last item relates to stolen identification 14 cards. Right now if you present a copy of your 15 police report, if your driver license has been 16 stolen and you present a copy of your police 17 report, those -- a replacement can be issued at no fee. And so what we'd like to do -- I think the 18 19 law was probably intended to also include 20 identification cards, so this law just adds 21 identification cards. If those folks present a 22 copy of the police report, we'll be able to issue 23 them a no-fee replacement for identification cards. 24

And the words may not necessarily be on the paper, but another issue that were related to a

1 cost -- a no-fee item relates to something the 2 Department is taking a look at right now, is 3 whenever you have a surviving spouse, being able to 4 obtain a no-fee title. So that is something that 5 the Department is taking a look at right now. 6 Whenever we have a surviving spouse, there are 7 charges in place to get those titles corrected. 8 So we're doing some fiscal impact analysis to 9 see what that might look like. I just wanted to 10 put it on your radar, and we'll come back and talk 11 to you guys about that, but it is something I 12 wanted to mention. And I'd be happy to answer any questions that 13 14 you have. 15 (NO RESPONSE). 16 MS. OLSON: Thanks Jennifer. 17 18 19 20 21 22 23 24 25

MONGIOVI: Okay. Agenda Item Number 2, 15 the OFR respectfully requests approval to publish a 16 notice of proposed rule for financial institutions 17 rules relating to family trust companies. 18 Are there any questions on Agenda Item 19 Number 2? 20 (NO RESPONSE). 21 MS. MONGIOVI: Agenda Item Number 3, the OFR 22 respectfully requests approval to publish notice of 23 proposed rule for financial institutions rules 24 relating to financial reports and semiannual 25 assessments for banks and trust companies.

The acquisition was negotiated by DACS under its Rural and Family Lands Protection Program. If approved, this will be the 29th perpetual conservation easement proposed for acquisition with a total of approximately 23,933 acres.

10 Lake Hatchineha Ranch property is a cow/calf 11 operation in Polk County. Approximately half the 12 property is heavily forested and supports a mix of 13 several natural communities, including large areas 14 of prairie hammock. The property is surrounded by 15 multiple large tracts of conservation lands, 16 including the Alan David Broussard Catfish Creek Preserve State Park; the South Florida Water 17 Management District's Kissimmee Chain of Lakes; and 18 19 our Rural and Family Lands project, K Rocker Ranch; 20 Everglades Headwaters Natural Wildlife Easement for 21 almost 800 acres; and there's also the Disney 22 Wilderness Preserve, over 11,000 acres; as well as 23 others.

This is a typical easement, and if you looked at the map in the backup, just about the entire

38 1 area of Lake Hatchineha is now conserved. 2 Any questions on that one? 3 MS. LEEDS: Hey, John, I'm sorry, I may have 4 missed this. Is the mitigation bank a private 5 mitigation bank, or is it public? 6 MR. BROWN: It's public. 7 MS. LEEDS: Okay. Thanks. MR. BROWN: And I'll double check just to make 8 9 sure of that. TNC is the mitigation bank, and I'm 10 almost absolutely sure it's public. 11 UNIDENTIFIED VOICE: We own it, yes. 12 MR. BROWN: Okay. Any other questions on that 13 easement? 14 (NO RESPONSE). 15 MR. Of course this project was ranked in tier one. It's a cow/calf operation. The family has been in the cattle business since the 1950s. The property is currently cow/calf and over mostly improved pasture; 200 acres is in hardwood hammock and 200 acres is in a wetland.

10 This property is available for industrial 11 development. It's alongside a railroad track and 12 also highway corridors there. It is under an 13 imminent threat of development, so this one has a 14 lot of pressure in a very sensitive area where 15 we're working on water.

So any questions on that one? (NO RESPONSE).

18 MR. BROWN: One of the things I'd like to call 19 to your attention, in the -- I guess on your copy 20 it would be about Page 3. It's the encumbrances 21 paragraph. Lastly, sort of an update, market condition update. Over the course of the last -- since we 6 met last two or three weeks ago, maybe more like a month ago, interest rates have gone up about 30 basis points, which is not unusual in and of 8 9 itself except for the fact that rates have been so 10 low for so long and things have been so good that the -- and it's all about the Fed. I mean that's 12 the bottom line. That's what every -- the 13 expectation is very high now that the Fed is going 14 to move again in December. And so this is the market -- an expected market reaction to that.
