### Addendum To: DEP Solicitation No. RFP 2021010, entitled Professional Services for Waste Management/Waste Cleanup Programs

## A. Clarification of Question and Answer #95

The Department has received multiple emails relating to Question and Answer #95 as posted in the VBS in Addendum 1. The Department does not answer questions about the substance of the solicitation outside of the designated question and answer period. However, upon further review of the Question and Answer #95, the Department believes it will be beneficial to all Respondents to clarify its response as follows:

By definition a "Primary Subcontractor" means a subcontractor(s) that will be used for professional services which the Respondent intends to use for the *term of the Contract*. Firms that are primarily surveying and/or structural engineering firms would typically not be considered a primary subcontractor under this solicitation unless the Respondent intends to use the firm for the *term of the Contract*. As an example, a professional surveyor could be included on a Respondent's submittal if the Respondent intends to use that surveyor as a member of their Contract "team" for the life of the Contract. More commonly, surveying/structural engineering firms would be subcontracted with selected firms on a site-specific basis and not for the term of the Contract that will result from this Solicitation. Therefore, if a Respondent chooses not to list a Primary Subcontractor on their response to the RFQ, that does not limit in any way a selected firm from using that subcontractor on future projects under the Contract that will result from this Solicitation.

Under this solicitation, a Primary Subcontractor will be considered a member of a selected firm's contract "team" whose associated rates will be included in the body of the Contract and are subject to annual contract rate negotiations. The resources and qualification of this Primary Subcontractor will be considered under the response package for the qualifying firm. For this reason, a Primary Subcontractor should not be included on multiple Respondent's submittals. There will be no "penalty" for listing a Primary Subcontractor that is also included on another Respondent's submittal. However, the Primary Subcontractor qualifications will not be considered as part of the response package.
