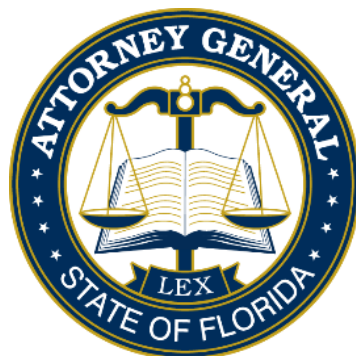

Contained herein are the responses to the questions submitted to the Department of Legal Affairs, Office of the Attorney General (Department) with regard to RFP DLA-2021-05, Website Modernization.
