The Bidder is required to bid all items in all three (3) Groups for their Bid to be considered responsive. For Group 3, Painting Tools and Supplies, the Department requires the Bidder to provide a Discount off MSRP for items including but not limited to: paint brushes, cut brushes, commercial grade paint rollers, commercial grade roller pans both bucket type and external pans, paint thinner, drop cloths, and roller extension poles. The discount is the Bidder's Bid for the items in Group 3.
2	Product being the same spec, however the Glidden product label will say Semi-Gloss versus the Sherwin label saying Gloss, will this be an issue?
