Section 1, DIRECT LABOR & FIELD OPERATIONS:

These rates (Rates per Unit) are to include all associated cost, including but not limited to overhead, fringe benefits and operating margin. Some projects may require work shift modification due to corridor access, traffic patterns, and/or the reduction of impact to the traveling public. Overtime is not anticipated for these shift change modifications. All cost for Quality Assurance / Quality Control and Accounting / Financial Management are overhead and are not billable.

Vendor staff attending any FDOT meetings within the District Four boundaries will not be compensated for travel time, fuel, or vehicle used. All work in Broward, Palm Beach, Martin, St. Lucie and Indian river counties, including the Miami-Dade Rail Corridor, will be paid as local. There will be no payment for travel or per diem for work within District four. There will be no additional payment of personnel mobilized to a site from outside of District Four (all cost should be included as part of the respective rates).

* Manager and Scientist classification includes those of Engineer, Chemist, Geologist, Hydrogeologist and Scientist.

Section 2, EQUIPMENT VEHICLES:

Where applicable, "Rate per Unit" price must include all cost associated with mobilization (delivery to site), demobilization (removal or pickup from site), maintenance, fuel, and operation.

**All work in Broward, Palm Beach, Martin, St. Lucie and Indian river counties, including the Miami-Dade Rail Corridor, will be paid as local. There will be no additional payment of personnel mobilized to a site from outside of District Four (all cost should be included as part of the respective rates). A one (1) day is a 10-hour shift. A weekly rate is based on four (4) working days, the monthly rate is based on twenty (20) working days. Any special equipment or attachment add-ons are to be listed under Non-Contract Items. Equipment listed in this section may not be subcontracted at a higher rate or cost.

Section 3, SAMPLING AND TREATMENT EQUIPMENT:

Labor for using the equipment in the field is not included in this Section. All work within the counties of District four is to be paid as the description in Section 2^{**} above.

Section 4, DRILLING:

Permanent monitoring wells are to be installed by a certified environmental well driller and according to regulatory agency specifications. Permanent monitoring wells and soil boring installation should be all inclusive (rate should include all labor, equipment, tools of trade, materials and locking well cap with lock). Hand-clearing for utility avoidance will be considered part of the well installation or Direct Push Technology process and cannot be charged as Soil Boring per foot rate. All drilling rates shall include the cost to restore the area to pre-existing condition (sod, asphalt, concrete, etc.). Additionally, all drilling rates are to include the cost of decontamination of equipment and steam cleaning when applicable.
