## **Contract for Commercial Off-The-Shelf Software**

# I. Scope of Work

This Contract sets forth the entire understanding of the parties. However, in the case of an ambiguity which requires extrinsic evidence to determine the intent of the parties, the following documents shall have priority in the order set forth below:
