Site Rehabilitation Services at Waste Cleanup Program Sites

Selected Firms will be required to address sites undergoing site rehabilitation activities under multiple program areas within the Waste Cleanup Program (WCP). It is understood that site rehabilitation tasks will vary significantly based on the complexity of each individual site and the goals and objectives of each program area.

The WCP is interested in the Firm's understanding, knowledge, and experience in contaminated site assessment and rehabilitation. The Firm will be expected to conduct site assessment activities in a manner that is consistent with the specific goals, objectives, rules and regulations applicable to each program area. The Firm must demonstrate its understanding and skill in site rehabilitation tasks including remedy selection, design, construction, operation and maintenance, monitoring, and closure. The Firm should demonstrate their knowledge and experience in providing technical support for federal facilities and NPL sites. The WCP is also interested in understanding the Contractor's knowledge and experience in addressing challenging environmental issues, such as per- and polyfluoroalkyl substances (PFAS), and their experience in providing community support and outreach. Throughout the presentation, the Firm should demonstrate their knowledge of the applicable rules and regulations, provide recommendations for schedule and cost controls, and provide details on how project management will be implemented.

Although cost controls may be discussed, the Firm shall not present any cost proposal information during its discussion. Cost proposal data shall be requested from the Firm(s) recommended for contract award and negotiated in accordance with Rule Chapter 62-787, F.A.C.

The discussion will be recorded by the Department and shall not last longer than sixty (60) minutes followed by a question-and-answer period, not to exceed fifteen (15) minutes. No more than five (5) people from the Firm may attend the oral discussions. Each Firm is responsible for providing all audio-visual equipment necessary to conduct its discussion. It is the Department's suggestion that the Firm bring its own MiFi/hot spot in case internet access is needed.

Oral discussions will be evaluated according to the criteria listed on the Oral Presentation/Discussion Scoring Criteria Form (attached).

The Firm must email the Procurement Officer with all written presentation material. If any of the material is considered confidential a redacted copy must be emailed as well.

Failure of a Firm to present the oral discussion within its scheduled timeframe shall preclude that Firm from further consideration for a contract award under this solicitation.

Scoring Method:

Oral discussions will be evaluated according to the criteria listed on the Oral Presentations/Discussions Evaluation Criteria Form. Each member of the Oral Evaluation Committee will assign a score from zero (0) to five (5) points for each of the criteria. Points will be assigned to each criterion as follows:

| Zero (0) Points | = the criterion is not addressed ; or is devoid of merit . |
|------------------|--|
| One (1) Point | = the criterion is poor ; contains significant deficiencies |
| Two (2) Points | = the criterion is fair ; contains some deficiencies |
| Three (3) Points | = the criterion is satisfactory ; no significant deficiencies |
| Four (4) Points | = the criterion is good ; contains some superior features |
| Five (5) Points | = the criterion is superior in most or all features |

The maximum total score a Firm can receive is Two Hundred Forty (240) points.

Following the completion of all oral presentations, each member of the Oral Evaluation Committee will rank the Firms in accordance with the scores given by that member. An average ranking will then be calculated from the ranking scores of all members of the Oral Evaluation Committee.
