PRIMARY SERVICES: Designation and Request to Change
Evidence Based Practices for the
Standardized Program Evaluation Protocol

The Standardized Program Evaluation Protocol (SPEP) is an assessment tool derived from meta-analytic research on the effectiveness of juvenile justice interventions. The tool is designed to compare existing intervention services, as implemented in the field, to the characteristics of the most effective intervention services found in the research. The SPEP scoring system is based upon the Primary Services that a provider uses in a program and the fidelity of the service delivery of those Primary Services. A separate SPEP evaluation is conducted, at the time of the program’s Quality Improvement Review, for each Primary Service provided by the program.

This information is kept on file for contract and Quality Improvement purposes. Once the requested designation or change is reviewed and approved, the Contract Manager will return the final form to the Provider and a copy will be kept in the contract file.

A separate designation form must be completed for each program component within a contract.

Instructions:

1. Complete Table 1: Provider Information. Use the Tab function to move between fields; *please sign electronically.*
2. **To Designate an Intervention as a Primary Service:**
 - a. To designate its Primary Services, the Provider will indicate which of its services, as enumerated in its contract, are a Primary Service.
 - b. Complete Table 2: Interventions and Primary Services. Not every intervention or primary service is listed in Table 2. If your intervention is not listed in Table 2, write it in the blank(s) provided.
 - c. For a new contract, use the contract effective date as the start date of the service.
 - d. Check those interventions which are to be considered a Primary Service.
 - e. Submit the completed form to the contract manager.
3. **To Discontinue an Intervention as a Primary Service:**
 - a. Update Table 2: Interventions and Primary Services.
 - b. Enter the date the intervention will be discontinued as a Primary Service.
 - c. Uncheck the intervention which no longer is designated as a Primary Service.
 - d. Follow the instructions *To Designate a Primary Service* if the discontinued intervention is being replaced with another service.
4. **To change a Primary Service:**
 - a. Follow the instructions *To Discontinue an Intervention as a Primary Service* and the instructions *To Designate an Intervention as a Primary Service.*
 - b. Submit the completed form to the contract manager.
 - c. The contract manager will schedule a meeting(s) with the Department’s review team and any requested meetings with the provider.
 - d. Once the request is reviewed by the team, Table 4 Approval will be completed.
 - e. The contract manager will notify the provider of the team’s decision, file this form in the contract file and submit the completed form to the provider, Programming & Technical Assistance, and the Office of Residential Services for SPEP record keeping purposes.
 - f. Should an amendment be required, Residential Services will initiate that process.
 - g. JJIS will be updated by the Office of Programming and Technical Assistance.
