(“TIBCO”) is the developer and publisher of the TIBCO FOCUS®, TIBCO WebFOCUS®, TIBCO Data Migrator®, TIBCO Service Manager®, and TIBCO Omni-Gen® product families (formerly known as the IBI FOCUS, WebFOCUS, iWay and Omni product families) comprised of proprietary software to which TIBCO holds trademarks, copyrights, and other intellectual property rights. TIBCO maintains the source code for the products and therefore is the only provider of the updates, maintenance, and support services for such software products once under license. TIBCO Software Inc. does not have resellers and no other purchasing mechanism is available.
