There are no alternative products that provide this functionality and meet DCF's needs. It would be very time consuming and costly to rewrite existing software sysems that have been integral to DCF since the late 1990's. The Workload Scheduler product provides job execution scheduling for Department of Transportation (DOT), Florida Department of Corrections (FDC), and Florida Department of Highway Safety and Motor Vehicles (HSMV). Changing products would require a complete redesign of the way jobs are scheduled for these agencies at the state data center.
