Failure to File Protest Within Prescribed Timeframe Statement: Failure to file a protest within the time prescribed in subsection 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under chapter 120, Florida Statutes.

Any person who is adversely affected by the terms, conditions, and specifications contained in a solicitation, including any provisions governing the methods for ranking bids, proposals, or replies, awarding contracts, reserving rights of further negotiation, or modifying or amending any contract shall file a written notice of protest with the Division within 72 hours (Saturdays, Sundays, and state holidays excluded) after the posting of the solicitation or decision or intended decision.

Notice of Protest Bonding Requirement: Any person who files an action protesting a decision or intended decision pertaining to contract awards administered by the Division pursuant to subsection 120.57(3), F.S., shall post with the Division, at the time of filing the formal written protest, a bond per subsection 287.042(2)(c), Florida

Statutes, payable to the Division of Emergency Management in an amount equal to one (1) percent of the Division's estimate of the total value of the contract, which bond shall be conditioned upon the payment of all costs, which may be adjudged against him in the administrative hearing in which the action is brought and in any subsequent appellate court proceeding. For protest of decisions or intended decisions of the State Purchasing Office, DMS, pertaining to the Division's request for approval of exceptional purchases, the bond shall be in the amount equal to one (1) percent of the Division's estimate of the contract amount for the exceptional purchase requested. In lieu of a bond, the Division may accept a cashier's check or money order in the amount of the bond. **FAILURE TO FILE THE PROPER BOND AT THE TIME OF FILING THE FORMAL PROTEST WILL RESULT IN A DENIAL OF THE PROTEST.**
