<p>The Bidder certifies that the Bidder is in compliance with Section 9 of the <a href="#">PUR 1001</a>, as modified by the ITB.</p>
<p>The Bidder certifies that the Bidder is not on the Scrutinized Companies with Activities in Sudan List, the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or the Scrutinized Companies that Boycott Israel List nor is it engaged in a boycott of Israel.</p>
<p>The Bidder certifies that, if awarded a Contract, and prior to execution of a Contract, it shall provide a PDF file of its current and active registration with the Florida Department of State, Division of Corporations, or, if exempt from registration, a statement to that effect noting the basis for the exemption. If Bidder is an out-of-state corporation, it certifies it will provide a Florida Certificate of Authority from the Florida Department of State, Division of Corporations prior to Contract execution. <p>The Bidder certifies that, if awarded a Contract, the Bidder shall provide documentation of its Motor Vehicle Repair Shops' current and active registrations with the Florida Department of Agriculture and Consumer Services, as required by the Florida Motor Vehicle Repair Act, sections 559.901 through 559.9221, F.S.. <b><u>This documentation is required for each Motor Vehicle Repair Shop operated by the Contractor that will provide Vehicle Maintenance and Repair Services under the awarded Contract.</u></b></p>
<p>The Bidder certifies that the Bidder is in compliance with section 448.095(2)(a), F.S., and that within the last year (i.e., within the last 365 days), it has not had a contract terminated under section 448.095(2)(c), F.S., by a public employer, as defined by section 448.095(1)(i), F.S.</p>
<p>The Bidder certifies it has provided to the Department an Attachment B, Price Sheet, fully completed in accordance with the instructions therein.</p>
<p>The Bidder certifies that it currently operates a minimum of three Motor Vehicle Repair Shops in the Region(s) bid and that, per each Region bid, the Bidder operates at least one 1 Motor Vehicle Repair Shop in each of the required counties as specified in the 'Motor Vehicle Repair Shops' section of Attachment A, Scope of Work and Attachment G, Regional Map, and that it meets or exceeds the requirements within Attachment A – Scope of Work. The Bidder has also completed Attachment H, Motor Vehicle Repair Shop Locations and provided with its bid submittal.</p>
