2	Need to be provided a full narrative on the details of Claim #: 093-0000679-2015. This claim is closed with a total incurred of \$23,213.34.	The Department does not have any further details regarding this claim.
3	Coverages requested specify no Uninsured Motorist coverage is needed; however, verification that State of Florida is declining the opportunity to have towing and rental reimbursement coverage quoted. 5	Please provide valid VINs for 2019 ASPT GT4. It is showing a VIN of FLA108390; however this VIN is coming up invalid.	FLA108390 is the correct VIN for the ASPT GT-4.
6	Please specify which vehicles are equipped with GPS monitoring devices.	The requested information is not in the possession of the Department.
7	Please describe the monitoring services provided.	The requested information is not in the possession of the Department.
8	Please provide description of driver safety programs currently implemented for all drivers.	There are no statewide driver safety programs. Each Named Insured would be responsible for any such programs and the Department is not in possession of this information.
9	How often are drivers required to receive updated driver safety training?	Each Named Insured would be responsible for any trainings and the Department is not in possession of this information.
10	Please describe any continuous training (in person or electronic) and education to improve driver safety.	Each Named Insured would be responsible for any trainings and the Department is not in possession of this information.



11	Please provide current Motor Vehicle Report (MVR) criteria for approved drivers.	The Department is not in possession of Motor Vehicle Record (MVR) report criteria.
12	Please provide how often the State of Florida the Motor Vehicle Reports (MVR) are reviewed.	The Department is not in possession of this information.

20	Please describe the use of the motorcycle currently on the vehicle schedule?	2015 HD FLHP VIN:1HD1FHM1XFB622928 is used for motorcycle safety demonstrations.
21	Please advise the use of the RVs currently on the vehicle schedule?	There are no RVs currently insured.
