2	Commissioner McCarty, good morning, sir.
3	MR. McCARTY: Good morning, Governor. Item Number
4	1, the office requests adoption of Rule 69O-186.017 for
5	the certificate of mortgage release according to
6	Florida Administrative Code, establishes an actuarially
7	sound principal for issuing certificates of mortgage
8	release recorded to Florida law.
9	CFO SINK: Move it.
10	ATTORNEY GENERAL McCOLLUM: Second.
11	GOVERNOR CRIST: Moved and seconded. Without
12	objection Item 1 is approved.
13	MR. McCARTY: Agenda Item Number 2, the office
14	requests approval to publish Rule 69O-138.002,
15	financial rate and market conduct examinations.
16	Governor, we request withdrawal of this rule for
17	consideration.
18	GOVERNOR CRIST: Show it withdrawn.
19	MR. McCARTY: Item Number 3 is to request approval
20	to publish Rule 69O-171.003, closed claims,

- 21 professional liability claims. This rule implements
- and mandates for the insurers to report to the Office
- of Insurance Regulation information to our closed
- claims database.
- 25 ATTORNEY GENERAL McCOLLUM: I move it.

1	CFO SINK: Second.
2	GOVERNOR CRIST: Moved and seconded. Without
3	objection Item 3 is approved.
4	MR. McCARTY: Item Number 4, the office requests
5	approval to publish Rule 69O-171.009. This is the same
6	medical malpractice database, but this relates to open
7	claims reporting.
8	GOVERNOR CRIST: Is there a motion?
9	ATTORNEY GENERAL McCOLLUM: I move to approve it
10	CFO SINK: Second.
11	GOVERNOR CRIST: Moved and seconded. Without
12	objection Item 4 is approved.
13	MR. McCARTY: Item Number 5 is the request to
14	approve to publish Rule 69O-167.014, alternative
15	methods for handwriting statements. Pursuant to the
16	legislation that was passed in the special session,
17	this rule will provide for alternative methods for
18	providing for those people with physical limitations to
19	provide for an alternative to a handwritten statement.
20	COMMISSIONER BRONSON: Motion on Item 5.

- 21 CFO SINK: Second.
- GOVERNOR CRIST: Moved and seconded. Without
- objection Item 5 is approved.
- MR. McCARTY: Thank you, Governor. Item Number 6
- is request for approval to publish Rule 69O-170.0155,

1	pursuant to the same House bill that passed in the
2	special session, which requires an affidavit to be
3	signed by a chief financial officer as well as a chief
4	actuary.
5	This needs to be fast-tracked because this has got
6	to be in place for filings made after March 1st.
7	ATTORNEY GENERAL McCOLLUM: I move it.
8	COMMISSIONER BRONSON: Second.
9	GOVERNOR CRIST: Moved and seconded. Without
10	objection Item 6 is approved.
11	MR. McCARTY: Item Number 7 is the office requests
12	approval for Citizens' amended plan of operation. As
13	you know, Citizens was ordered to hold a series of
14	public hearings to take public input to improve the
15	quality of service. The office, in cooperation with
16	Citizens staff, has completed those public hearings.
17	We also set up a Web site, Citizens For Better
18	Citizens, and received over a thousand requests from
19	citizens on how to improve the quality of their plan of
20	operation.

- Today the chairman of the board, Bruce Douglas, is
- here to make a presentation as to the changes to their
- plan of operation.
- GOVERNOR CRIST: Very good.
- MR. DOUGLAS: Good morning. I am pleased to tell

1	you that the amended plan of operation requested at the
2	September Cabinet meeting is now totally
3	consumer-focused. We have had, as the commissioner has
4	pointed out, public meetings. I must say that most of
5	the input we got related to rates. But we did get some
6	input as related to service levels.
7	We're proud that the service levels that Citizens
8	is now offering in the way of claim handling has
9	improved dramatically over the past two years. And I
10	believe the plan of operation is exactly what was
11	requested at the last or at the September Cabinet
12	meeting.
13	And I'll be glad to answer any questions you may
14	have.
15	GOVERNOR CRIST: Any questions? Commissioner?
16	COMMISSIONER BRONSON: Yes, Governor. One of the
17	things that I was concerned about, because of the size
18	that Citizens was potentially going to grow, is do we
19	have enough personnel that can actually get out and
20	work those claims and get them in in a timely manner so

- 21 that the citizenry didn't feel like they were unduly
- set aside for such a long length of time. Do we have
- enough people out there to do that job?
- MR. DOUGLAS: Well, Commissioner, we have 2,000
- licensed independent adjustors ready to handle what we

1	used to have to handle scrambling with a couple of
2	hundred. We think we're ready. But, again, depending
3	upon the size of the storm and the area that it hits,
4	you never have enough. But we think 2,000 is about
5	right to handle the needs. It's a far cry from where
6	we were historically.
7	GOVERNOR CRIST: CFO Sink?
8	CFO SINK: Governor. Bruce, I was reading over
9	the declaration of rights, and it's very well written.
10	I guess the next step is, how are you going to
11	implement and then measure and monitor this commitment
12	to your policyholders?
13	MR. DOUGLAS: Well, we're going to do it a couple
14	of ways. One, our experience with holding public
15	meetings in '06, we're going to carry that through to
16	'07 and years to go. On a quarterly basis we're going
17	to meet in areas where we have the largest number of
18	policies, listen to the people. We're going to do it
19	by direct mail.
20	We're going to do it through our agents. We have

- 8,500 agents. We have set up systems internally to
- police how we're doing, evaluate how we're doing. We
- have strengthened the internal audit operation in
- 24 Citizens. We've employed Derry Harper, the former
- inspector general from the Governor's Office.

1	And we're going to measure every possible way now
2	we're doing in the eyes of the consumer, not in the
3	opinion of someone else.
4	We think we're on the right track, and I would
5	defer to anyone saying, well, here are the complaints
6	we've had. I was so proud of our people on how they
7	handled the last 60 days in Central Florida. I think
8	85 percent of those claims are closed, and we're only
9	on the 13th of February.
10	So our declaration of rights is not just a piece
11	of paper. It's a way of life. In all deference to the
12	Governor, we would like to call Citizens Property
13	Insurance the people's company because it is.
14	CFO SINK: Thank you, Bruce.
15	GOVERNOR CRIST: I want to commend you, too. I've
16	been down to Central Florida about six times since the
17	tornados hit, and you've had people on the ground every
18	time I've been there. So thank you for that. General,
19	did you
20	ATTORNEY GENERAL McCOLLUM: I have a question.

- Good to see you, Bruce. In terms of the agents that we
- have in the field that you engage, are they general
- lines agents, in other words, they have other companies
- they represent? Some insurance companies have only
- 25 their exclusive agents.

MR. DOUGLAS: These are independent agents. They 1 2 represent other people, if there are other people. 3 ATTORNEY GENERAL McCOLLUM: That's what I wanted 4 to know. I figured that they did, and that probably 5 gets us out there better than the other way around. 6 That's all, curious. Thank you. MR. DOUGLAS: Thank you. 7 8 GOVERNOR CRIST: Thank you. Is there a motion on 9 Item 7? 10 COMMISSIONER BRONSON: Motion on Item 7. 11 ATTORNEY GENERAL McCOLLUM: Second. 12 GOVERNOR CRIST: Moved and seconded. Without 13 objection, Item 7 is approved. Thank you very much. 14 MR. DOUGLAS: Thank you. 15 GOVERNOR CRIST: Thank you, Commissioner. 16 CFO SINK: Governor. 17 GOVERNOR CRIST: Yes. CFO SINK: Kevin, would you share with the Cabinet 18 what we're getting ready to do on Thursday up in 19 20 Atlanta? I think it's important for them to be aware

- of some of these other activities that might help
- stabilize our insurance market in the state. Thank
- you.
- MR. McCARTY: Thank you. We are in the process of
- organizing a multi-state catastrophe fund. Florida

1	chairs the National Association of Insurance
2	Commissioners' Committee on Property Insurance, and
3	we've been working a number of years developing a
4	national program to promote at the federal level to
5	help bring stability, not only to Florida but to all
6	the states that have a moderate to severe risk of a
7	catastrophic event.
8	We hear so much about the hurricanes in Florida,
9	but we know that there's a potential of a \$400 billion
10	loss in California from an earthquake or a 250 billion
11	loss in the New Madrid Fault if they were to have an
12	earthquake event there.
13	So what we're attempting to do is bring together
14	insurance commissioners as well as computer modelers
15	and interstate compact experts and looking at what we
16	can do on a state-based solution, partnering with
17	states around the country that have this risk,
18	recognize this risk and are looking at alternatives to
19	the federal government.
20	So on Thursday and Friday in Atlanta, the State of

Florida has organized, through the National Association
of Insurance Commissioners, a summit to come up with a
work product on some alternatives to a federal solution
and teaming the states together to form a catastrophe
fund that will build on the good work we've done here

1	in Florida.
2	CFO SINK: Thanks. And, Governor, can I I'd
3	just like to ask Kevin one more question. I guess two
4	weeks ago today the insurance consumer advocate, Steve
5	Burgess, and Steve Alexander, the actuary in the
6	Consumer Advocate Department, presented at a hearing
7	regarding medical malpractice insurance rates.
8	And I understand that the basis of their
9	presentation is that they believe that med mal rates
10	are still too high and that perhaps the OIR did not
11	take into account some other factors that could drive
12	these rates further down.
13	And would you just clarify for us what is the next
14	step in that process?
15	MR. McCARTY: Sure. At the request of the
16	consumer advocate, the office scheduled two workshops
17	last week, two public hearings, one dealing with a
18	specific company on their rate filing and another in
19	general, to put forth evidence as to whether or not
20	that the legislative changes on medical malpractice in

23

- 21 fact have resulted in the rate reductions that were 22 anticipated by the Legislature.
- We are in the process of -- the record is still open. We're looking at the details of that, and we're 24
- 25 coming back with a recommendation. In first look at

1	this, we would recommend going forward and requesting
2	legislation or special budget amendment to give the
3	office the authority to republish a presumed factor.
4	And by doing that, we would use that presumed
5	factor and require the insurance companies providing
6	medical malpractice coverage to make a filing and
7	demonstrate that they have, in fact, recognized all the
8	savings in the legislation that was passed two years
9	ago.
10	CFO SINK: Thank you.
11	GOVERNOR CRIST: Thank you, Kevin.
12	MR. McCARTY: Thank you very much.

1	GOVERNOR CRIST: FDLE. Commissioner, good
2	morning.
3	MR. BAILEY: Good morning, Governor, members of
4	the Cabinet. I have four items for your consideration
5	this morning. First is our minutes from the October 3,
6	2006, Cabinet meeting.
7	COMMISSIONER BRONSON: Motion on Item 1.
8	ATTORNEY GENERAL McCOLLUM: Second.
9	GOVERNOR CRIST: Moved and seconded. Without
10	objection.
11	MR. BAILEY: The second item is our first quarter
12	performance report and purchases over \$100,000. You
13	will see that our performance for both quarters one and
14	two are relatively consistent. In each case you'll see
15	that we are on track to meet almost all of our
16	measures.
17	And as you've heard from me before, our biggest
18	challenge continues to be our crime laboratories.
19	You're familiar with the growth in submissions and in
20	some ways that we are tackling that. And I'm proud to

- 21 report to you this morning that we are starting to see
- results.
- Compared with the same time period last year,
- we've completed 5,000 more crime laboratory cases.
- 25 That's an 11 percent increase in productivity.

1	Since I
2	GOVERNOR CRIST: Go ahead. Sorry.
3	MR. BAILEY: Since I've come on board, Governor,
4	we have decreased our backlogs by 48 percent. Now,
5	that's overall. I wish I could tell you that that was
6	DNA, but that is our overall. We're still struggling.
7	The DNA backlogs are not nearly as backlog
8	reductions are not nearly as significant as the other
9	others, but we're getting there.
10	We now have robotics in place with each of our
11	laboratories, with the exception of Pensacola.
12	Pensacola is behind because of the hurricane damage to
13	that laboratory and the rebuilding that we had to do
14	there.
15	We've now outsourced a fairly good portion of our
16	DNA cases, about 750 to a certified private laboratory.
17	And last week we began a new efficiency initiative that
18	I'm very excited about. We've contracted with a
19	federally funded forensic laboratory in Largo. And
20	what they're doing for us is they're training our local

law enforcement officers from some of our high input
agencies, the ones that bring us a lot of our material.

They're training them to be more selective in the
evidence that they submit. They're going to do
prescreening. So from them we're getting quality

evidence for analysis rather than volume. And that's 1 going to help us quite a bit. It will take a little 2 while for that to start showing the results. But this 3 is the first of several classes where we're going to 4 get sheriffs and chiefs to do some of our work for us. 5 6 You're going to see continuing progress with the DNA backlogs. 7 8 GOVERNOR CRIST: Great. Thank you. 9 ATTORNEY GENERAL McCOLLUM: Question, Governor. GOVERNOR CRIST: Yes, General. 10 11 ATTORNEY GENERAL McCOLLUM: Commissioner Bailey, 12 you indicated what we've done to work more cases off in 13 the last year. Have we had an increase or has it 14 remained steady with regard to the caseload that you're 15 getting in, new cases each year? 16 MR. BAILEY: It's increasing, especially DNA. And 17 part of the reason for that is that our law enforcement agencies are discovering new and interesting ways that 18 19 they can use DNA.

20

And a good example of that is back several years

- ago you pretty much had to have a sample of a body
- fluid for us to do DNA on it. Then it took several
- days to get that. Now, they can swab a doorknob and
- just get skin cells, and the turnaround time is much
- 25 quicker.

1	And bottom line, our resources have not kept pace
2	with the advancing technology of what we can do with
3	this exciting science, and we're having to come up with
4	innovative ways, such as the screening process the
5	officers are being taught in Largo. But to answer your
6	question directly, it is increasing.
7	ATTORNEY GENERAL McCOLLUM: Well, I know you have
8	a budget request increase in to help you do all this,
9	and I was in committee the other day following one of
10	your staff presentations and commented on it. Anytime
11	any of us can help you encourage the Legislature to
12	give you the resources you need, just let us know.
13	MR. BAILEY: Thank you. Let me mention, one key
14	issue in that budget item is the outsourcing of the
15	training. The way FDLE had done business in the past,
16	we had used our in-house cadre to train the rookies,
17	the new kids coming in.
18	That took a qualified, experienced analyst off the
19	bench to do basic training. So it was
20	counterproductive in that neither were doing case work.

- Now we have, as part of our budget request, funds
- to have that training done outside by certified
- professionals, and then they'll come back to us and do
- 24 the work.
- 25 ATTORNEY GENERAL McCOLLUM: Well, I think you're

to be commended for what you've done in the short time 1 you've had to work on this. I know there's a lot more 2 to do. But, really, thank you for what you're doing. 3 4 MR. BAILEY: Thank you. 5 GOVERNOR CRIST: Thank you. CFO SINK: Governor. 6 **GOVERNOR CRIST: CFO?** 7 CFO SINK: I have just a quick question. You 8 9 mentioned that one of the solutions is to outsource more of the DNA testing to private companies. Is that 10 a fairly common practice across states? And also how 11 12 do you assure that there's good quality work being done 13 at the labs that we're -- the private labs? 14 MR. BAILEY: Yes, it is a common practice, and as a matter of fact, there's a draft letter, a white 15 16 paper, if you will, about to be issued by the National 17 Governors' Association that pretty well outlines what they're calling the DNA crisis in the country. 18 And they have several points on what we can do to 19

20

overcome that. And one of those is outsourcing it to

- 21 private laboratories.
- We only use certified laboratories. There is a
- certifying body there. And these laboratories are --
- not only are they trained in the analysis of the
- samples. They understand chain of evidence and

1	courtroom testimony as well.
2	CFO SINK: Okay. Thank you.
3	GOVERNOR CRIST: Thank you. Is there a motion on
4	Item 2?
5	ATTORNEY GENERAL McCOLLUM: I move Item 2.
6	COMMISSIONER BRONSON: Second.
7	GOVERNOR CRIST: Moved and seconded. Without
8	objection Item 2 is approved.
9	MR. BAILEY: Our third item is our second quarter
10	performance report and purchases over \$100,000. That
11	report pretty well reflects and tracks the one I've
12	just given you. Now, there is one issue that has come
13	up during that quarter, is we are the investigative
14	group, if you will, for the rasinos, the
15	State-monitored casinos that are about to come online.
16	Two opened at the end of last calendar year, and
17	we have another one going to come online next month.
18	And, again, we're working now with the local law
19	enforcement and the security folks assigned to those to
20	set the pace and figure out the protocols of how we're

- 21 going to be the investigative arm for this casino
- 22 initiative.
- You'll be hearing more from us as the casinos get
- up and running and we actually start to get our people
- in place.

1	GOVERNOR CRIST: Is there a motion on Item 3?
2	COMMISSIONER BRONSON: Motion.
3	CFO SINK: Second.
4	GOVERNOR CRIST: Moved and seconded. Without
5	objection Item 3 is approved. Item 4.
6	MR. BAILEY: The fourth item is 12 rules that
7	we're offering for your consideration. They are
8	primarily housekeeping and responses to legislative
9	changes. With your approval, I would like to highlight
10	two or three of them.
11	GOVERNOR CRIST: Please.
12	MR. BAILEY: The bulk of the rules are coming from
13	our Criminal Justice Standards and Training Commission,
14	Rule 11B-35 is a, again, response to new legislation.
15	And what that one does, it adds six hours of taser
16	training for new law enforcement officers, and it is
17	four hours of human trafficking training. It's a
18	response to the growing problem that we have in our
19	state with the human trafficking problem. So, again,
20	that is for new officers. It will be part of the basic

- 21 curriculum as they come on board.
- Rule 11G-2 involves our Medical Examiners'
- Commission. As you know, we act as staff to that
- 24 commission. They have started an initiative on the
- 25 identification of unidentified remains. This is a

1	response to that that will require the medical
2	examiners to maintain bone and tissue samples for the
3	duration, to help future identifications of
4	unidentified remains.
5	GOVERNOR CRIST: Any questions on the rule
6	changes? Is there a motion?
7	ATTORNEY GENERAL McCOLLUM: Governor, I move to
8	approve them.
9	CFO SINK: Second.
10	GOVERNOR CRIST: Moved and seconded. Without
11	objection Item 4 is approved. Thank you very much,
12	Commissioner.
13	MR. BAILEY: Thank you.

1	GOVERNOR CRIST: Next, Board of Trustees.
2	Secretary Sole.
3	MR. SOLE: Good morning, Governor, Cabinet
4	members. Item Number 1 is submittal of the Board of
5	Trustees minutes from actually several board agendas,
6	November 14th, December 5th and December 19th of 2006
7	for the Department, Southwest Florida Water Management
8	District's August 15th Cabinet meeting, and finally St.
9	Johns River Water Management District's January 29th
10	and February 27th, 2002, Cabinet meetings.
11	GOVERNOR CRIST: We will ask that you certify that
12	these are all correct before you ask somebody to make a
13	motion up here. Can you do that for us?
14	MR. SOLE: Absolutely, Governor. We've gone
15	through the minutes and, in fact, actually go through
16	the transcripts of those agenda items to verify that
17	the actions in these minutes are recorded accurately.
18	There's quality assurance in that process, which
19	includes actually a double review to make sure they are
20	accurate. Yes. sir.

- GOVERNOR CRIST: Thank you. Is there a motion?
- 22 COMMISSIONER BRONSON: Motion on Item 1.
- 23 ATTORNEY GENERAL McCOLLUM: Second.
- GOVERNOR CRIST: Moved and seconded. Without
- objection the minutes are approved. Item 2.

1	MR. SOLE: Thank you. Item Number 2 is
2	consideration of an agreement to acquire 1,286 acres
3	under the Florida Fish and Wildlife Conservation
4	Commission's Fish and Wildlife Habitat Program from the
5	Nature Conservancy.
6	The project is known as Barry's Ranch and is
7	located in Alachua County. The Trustees' purchase
8	price is \$10,060,000, which is approximately 98 percent
9	of the appraised value. The acquisition area is
10	partially within the Watermelon Pond Florida Forever
11	Project, but the funds to acquire this are actually
12	being funded through the Fish and Wildlife Conservation
13	Commissions's Fish and Wildlife Habitat Program, which
14	is established under statute to acquire managed lands
15	that are important to fish and wildlife.
16	The Barry's Ranch is a mosaic of natural
17	communities and is going to primarily provide habitat
18	to the gopher tortoise as well as the Sherman's fox
19	squirrel. And the property will be managed by the Fish
20	and Wildlife Conservation Commission.

- GOVERNOR CRIST: Is there a motion on Item 2?
- 22 CFO SINK: I move it.
- 23 ATTORNEY GENERAL McCOLLUM: Before we vote on
- 24 it --
- 25 GOVERNOR CRIST: General.

1	ATTORNEY GENERAL McCOLLUM: Governor, 1d jus
2	like to ask, as far as the mitigation for gopher
3	tortoises are concerned, is this a venue where you're
4	likely to have gophers transported from somewhere else
5	to this property, or is this just for the protection of
6	the gophers that are on that property currently?
7	MR. SOLE: I'd like to defer to Gary Cochran with
8	the Fish and Wildlife Conservation Commission, if I
9	can, General.
10	MR. COCHRAN: Good morning.
11	ATTORNEY GENERAL McCOLLUM: Good morning.
12	MR. COCHRAN: Governor, members of the Cabinet.
13	General McCollum, this site will be evaluated to
14	determine if it is an appropriate restocking site.
15	Right now we don't believe that that will be the case,
16	but there are some areas on the site that have been
17	used more actively for agricultural practices in the
18	past.
19	Those areas, over time, will be restored, and it
20	is possible that some of those areas may be, at some

- 21 point in time, deemed suitable for relocation. But at
- this time we are not planning on this specific site.
- 23 ATTORNEY GENERAL McCOLLUM: I just wondered, from
- the description, it sounded like we might be doing
- 25 that.

1	MR. COCHRAN: We may do that. That is under
2	active review and research by the Commission
3	scientists. We are currently working on developing new
4	rules governing the Gopher Tortoise Mitigation Program.
5	And among the many policies we are considering is
6	restocking sites elsewhere in the state, both on
7	private lands and on public lands.
8	ATTORNEY GENERAL McCOLLUM: I've been concerned
9	for some time about the fact that the rules allowed for
10	some developers to have a little tradeoff so they could
11	literally eliminate the gopher tortoises physically,
12	you know, exterminate them as part of their tradeoff in
13	the development process.
14	Whereas, it seemed to me, if you had more land
15	available and it made it easier for the relocation of
16	these tortoises, we'd be saving their lives, not just
17	having a mitigation in the environment tradeoff, like
18	so many of them have done. So that's why I asked the
19	question. I hope you're able to use this land. If
20	not maybe there's some more out there

MR. COCHRAN: Well, there is. We have a number of sites that have just recently been certified that are private ownership lands that are acceptable for gopher tortoise restocking, and we are evaluating publicly held lands as well.

1	ATTORNEY GENERAL McCOLLUM: I'll second the
2	approval.
3	GOVERNOR CRIST: We have a motion and a second.
4	Without objection show Item 2 approved.
5	MR. SOLE: Thank you, Governor, Cabinet.
6	GOVERNOR CRIST: Thank you very much, Secretary.
