Performance Explanation

¹ <u>Average number of days to complete lab service requests</u> – The Department has cut its laboratory backlog by over 60% this fiscal year through implementation of the 10-point plan. As part of the plan, FDLE has purchased robotics for DNA sections across the state, developed new case acceptance guidelines, implemented more effective workload and staffing management practices, maximized overtime use, and outsourced DNA backlogs to other private, accredited labs. As the backlog is reduced and aged cases are worked, the turn-around times are inflated. Still, while the standards in many of the disciplines were not achieved this year, turn-around times were improved compared to last year.

² <u>Number of criminal investigations worked</u> – FDLE is committed to working complex, protracted high impact criminal investigations. Because of their complexity, they are lengthy and labor intensive. This results in investigators investing more hours in a fewer number of cases over a long period of time.

³ <u>Number of domestic security concerns reported and responded to by Regional Domestic Security</u> <u>Task Forces</u> – This measure captures the number of tips and cases entered into the In-Site database. The Regional Domestic Security Task Forces (RDSTF) responded to all significant domestic security concerns reported by citizens, business entities, local, state, or federal law enforcement or governmental entities. Not as many tips and cases were received as anticipated.

⁴ <u>Amount of fraudulent benefits withheld as a result of public assistance fraud investigations &</u> <u>Number of public assistance fraud investigations conducted</u> – Changes in federal food stamp program policies have resulted in a decrease of the number of administrative hearing referrals received. Additionally, the PAF program is engaged in more significant, complex criminal investigations which require more time and effort to investigate, resulting in fewer case closures.

⁵ Number of domestic security training courses delivered – Between 2002 and 2004, emphasis was placed on FDLE delivering domestic security training. As a result, most existing law enforcement personnel have received required training. Only new law enforcement officers and first responders now require training. Additionally, domestic security training courses are available online and at the local level. This has resulted in a decrease in the number of training courses provided through certified training schools.
